**Public Hearing and Notice of Availability of the
Community Development Block Grant (CDBG)
2026 Annual Action Plan
Proposed Use of Funds**

The Village of Hoffman Estates seeks input for its Annual Action Plan for Program Year 2026. The 2026 Program Year begins on October 1, 2026 and ends on September 30, 2027. The Plans identify the Village’s strategy to address affordable housing, infrastructure improvements, supportive services, and community development needs of low and moderate income residents. The CDBG program is a federally funded program intended to develop a viable community, a suitable living environment, and expanded economic opportunities principally for low and moderate income residents of Hoffman Estates.

The Village of Hoffman Estates anticipates an allocation of approximately \$238,046 in CDBG funds during the 2026 Program Year. The Annual Action Plan includes activities that the Village proposes to complete with the anticipated CDBG funds in order to benefit residents of low and moderate income and meet Consolidated Plan objectives. Past year funds have open projects in other project areas.
