VILLAGE OF HOFFMAN ESTATES, ILLINOIS

1. Time and Place of Opening Bids. Sealed proposals for the completion of the 2019 Sanitary Sewer Lining for the Village of Hoffman Estates, Cook County, Illinois, will be received at the Office of the Village Clerk at 1900 Hassell Road, Hoffman Estates, Illinois 60169 until 10:00 A.M., October 16, 2019, and at that time will be publicly opened and unit price total read aloud.

2. Description of Work. The proposed construction consists of approximately 3,500 feet of 8-inch diameter sanitary sewer manhole-to-manhole lining with cured-in-place pipe (CIPP), and other miscellaneous items of work.

Not less than the prevailing rate of wages as determined by the Department of Labor or determined by the court on review shall be paid to all laborers, workmen and mechanics performing work under this contract.

The Village of Hoffman Estates is exempt from the Illinois State, municipal or county Retailers Occupation Tax, Service Occupation Tax, Use Tax, and Service Use Tax as described in Illinois Compiled Statute Chapter 35. Bid prices shall not include the cost of such taxes.

All Bids must be accompanied by a Bidder's bond, certified check, bank cashier's check or bank draft payable to the Village of Hoffman Estates for ten percent (10%) of the total amount of the Bid as provided in the Bidder Instructions.

4. Rejection of Bids. The Village of Hoffman Estates reserves the right to waive any/all informality, or to reject any/all Bids and/or parts thereof; and to accept that bid which it deems most favorable to Hoffman Estates after all bids have been examined and canvassed.
